#### Heather Asher

#### Q. What is your role at CCUR Holdings, Inc.?

I came on full time at my company right after the sale of a business division. We sold another division about six months later and recently acquired a new business. CCUR Holdings is actively pursuing business opportunities including assets for acquisition and continued development of its real estate and merchant cash advance operations through its subsidiaries.

#### Q. What is your biggest legal challenge?

Working through these transition periods has been an intellectual challenge that keeps my job interesting. There is not really a guidebook available because any transition process is going to be very specific to the business.

#### Q. What keeps you up at night?

What keeps me up at night is figuring out the questions that I haven't asked. In my experience as a solo in-house attorney, I have found it important to be proactive in keeping up to date on legal news and trends. Interacting at ACC events with other in-house attorneys who are part of small legal departments has been very helpful. The daily email digest that I receive from the ACC has also been a great resource.

#### Q. What makes a successful leader?

Being knowledgeable about the work contributions of your colleagues can contribute to your own success. Learning about what people are working on daily can help you figure out the type of support they need to be successful and how you can assist. People usually return that support in kind, and it can make them feel invested in making sure that you are successful.

#### Q. What is your best advice for outside lawyers?

My advice for outside counsel is to become as familiar as you can with your client's business. A firm that is able to help spot issues is a valuable partner. Understanding the company's business and goals will help you figure out areas of need (and opportunities for the firm) that the company may not have identified yet.

#### Q. What keeps you busy outside of work?

Two little kids and a large extended network of family and friends (I am born and raised in Atlanta) keep me busy. My weekends are usually booked out a few months ahead with birthday parties, soccer games, bridal showers and various social gatherings.


#### IN-HOUSE SPOTLIGHT

#### Q. What is your role in the legal department?

For nearly a decade, the ACC Georgia Value Challenge has provided in-house counsel with updates on timely legal issues while raising money to support the Pro Bono Partnership of Atlanta. #### Polsinelli Encourages Teamwork Between Litigators and Transactional Lawyers to Avoid Trouble Down the Road

Sponsored by the Atlanta office of Polsinelli PC, an Am Law 100 national law firm, February's ACC Georgia CLE luncheon series explored the benefits of consulting litigators during contract negotiations. Using a fictional outsourcing agreement as a case study, Polsinelli shareholders Leslie F. Spasser, William Hill, David Gordon and Atlanta office Managing Partner Brian McEvoy discussed the consequences of taking shortcuts and avoiding difficult issues during contract negotiations – in terms of increasing the likelihood of litigation and impairing a party's position if litigation begins.

"Terms included – or omitted – by transactional lawyers can make or break future litigation," explained Spasser. "It's critical that transactional lawyers leverage the expertise of litigators as part of their negotiation strategy to prevent negative impacts to the firm."

Representing experience across multiple industries and legal areas of focus, the Polsinelli panelists emphasized the importance of leveraging team personnel assets in every stage of the contract lifecycle to capitalize on best practices. By connecting transactional lawyers with litigators early on, in-house legal teams can break through the responsibility-specific silos in which lawyers frequently operate to create better business results. By theorizing possible bad outcomes up front and understanding how contract terms play out in litigation, in-house counsel can negotiate robust contract terms that best protect the business.

Polsinelli applied this strategy to an outsourcing scenario – a topic of much interest to the crowd in attendance. For small and large businesses alike, outsourcing business functions to vendors can reduce internal headcount, operational costs and capital investment. However, by transferring management of any function to a third party, the firm becomes vulnerable if the outside vendor does not or cannot perform the services as contracted. Because they understand their company's business and operational characteristics, in-house lawyers play a critical role in negotiating outsourcing agreements that protect their company against adverse consequences if a vendor fails to perform.

Starting with a basic IT outsourcing agreement, the panel explored real-life situations that could play out once the fictional parties began performing (or not performing). In this case, the fictional IT vendor provided inconsistent technical support to the business, mishandled company information and equipment and exposed personal customer information to criminals. As a result, the customer offered inconsistent services to its clients, resulting in loss of revenue and unforeseen mitigation costs and an investigation by the FBI. The panelists outlined a multilayered approach by which counsel can mitigate the risk of these types of disastrous outcomes:

- Performing financial due diligence up front on the vendor
- Demanding third-party beneficiary rights with key suppliers in the event that the vendor cannot pay its suppliers
- Monitoring financial solvency of vendor through quarterly financial reviews
- Establishing a source code escrow for critical software and looking at analogous solutions for software as a service vendor

Audience members were particularly interested in how they could use contractual terms to protect the business in the event of a vendor bankruptcy.

Transactional lawyers can provide better business results when they leverage the expertise of litigators as part of their negotiation strategy – just as litigators benefit from transactional lawyers' interpretation of contractual terms during legal proceedings. Further, by citing real life examples of possible adverse outcomes, lawyers can better communicate the importance of engaging vigorous negotiations to their internal clients.



## **Sponsorships and Programs Committee**
