**Coaching Sessions** – Face-to-face, telephone, Zoom, and Skype sessions are typically held on a bi-weekly or monthly basis at a specified time and can last from one to three hours. Clients drive the topics of the sessions. Debra expertly guides agendas and discussions and keeps her clients focused on and aligned with their intentions and goals. In Debra's experience, successful individual coaching engagements require at least six months of sessions, with many lasting up to a year or longer.

Debra has created customized communication skills, leadership, practice and time management, business development, networking and relationship building group coaching programs at many organizations. Group coaching sessions will typically be held monthly and continue as needed.
