TAKEAWAYS FROM THIS CLASS:

Regardless of how well managed, every business will have to deal with some sort of wrongdoing, whether it may be the result of an employee's willful misconduct or an unfortunate lapse in judgment. The severity of the wrongdoing can range from failure to follow internal policies and requirements, to action in violation of law. Depending upon the severity of the matter, the interest of federal, state, or local authorities, regulators or worse, prosecutors may be triggered.

This class will help you to gain perspectives on the following:

- The role of the in-house counsel in an internal investigation and the career trajectory and background that helps prepare for the role of director of internal investigations.
- Spot and assess the circumstances where an internal investigation may be necessary.
- Evaluate whether an investigation should be conducted in-house versus when retention of outside counsel is necessary/advisable.
- Understand the issues concerning attorney/privilege as applied to internal investigations and how to preserve the client's ability to assert privilege to the extent possible
- Determine if, when, and how to interface with government attorneys
- Explore how remote work and the COVID-19 pandemic have impacted the ability to conduct effective internal investigations
